

CORONAVIRUS 2019 (COVID-19)



Background Information

COVID-19 was discovered in December 2019 in the city of Wuhan, Hubei Province, China. It is an aggressive respiratory infection that is believed to be transmitted through droplet spread when infected people cough or sneeze. The virus can gain access to the body through the respiratory tract, mainly through the nose and mouth. Symptoms are similar to the common influenza strain and include fever, cough, muscle pain, shortness of breath, and fatigue.

Initially isolated to mainland China, the World Health Organization (WHO) is reporting for the first time that there are more new cases being discovered outside China than from within China.¹ As of their March 1 report, the WHO is reporting 87,137 confirmed cases, with only 7,169 of those outside of China.²

In the United States, The Centers for Disease Control and Prevention (CDC) is reporting 494 presumptive positive cases of COVID-19, meaning they have tested positive by a public health laboratory and are pending confirmation by the CDC. This includes at least 2 cases of where the virus was contracted by individuals with no relevant travel history.³ The first death due to COVID-19 in the United States was reported in Washington State on February 29⁴.

Regarding travel, the CDC has issued the following recommendations⁵:

- Warning (Level 3) – avoid all non-essential travel to China, South Korea, Italy, and Iran. Entry of foreign nationals from China and Iran into the U.S. has been suspended.
- Alert (Level 2) – older adults and those with chronic medical conditions should consider postponing travel to Japan.
- Watch (Level 1) – use regular travel precautions for travel to Hong Kong.

ACA Italy:

Early Departure from Program

Due to the unfortunate fact that Italy was put on a Level 3 Travel Advisory (Feb 29, 2020), all students were given the opportunity to choose to take their second quarter final exams early and return home. Per the request of some universities – arrangements were made to facilitate their student's ability to take their second quarter final exams at their home university. This special accommodation was solely made for our program in Italy - due to the Level 3 Travel Advisory.

All Other ACA Programs:

ACA does not intend to close any of the programs unless otherwise required by local governments or the US State Department. As of now, all ACA programs are still in session. Classes have not been interrupted, though some adjustments have been made to cultural tours in order to ensure the safety of all students.

Added safety measures are being put in place at each program. These measures will affect student's personal travel plans and possibly their participation in the programs' planned cultural tours. If a student shows any signs of a contagious disease (such as the common cold or flu), they may be asked to remain in their dorm room on campus in consideration of their safety and the safety of the other students. In the unfortunate event that a student shows any symptoms of COVID-19, they will immediately be taken to the nearest hospital.

The decision to remain in any ACA program implies that the student is committing to follow all the safety measures indicated by their program director. Failure to follow the measures implemented at any ACA program will result in immediate expulsion from the ACA program.

Third Quarter (Mar-May/Jun 2020)

ACA is following the information provided by official sources such as the CDC and US State Department. As of now - Italy is the only country where we have a program that has an official travel advisory (Level 3). All the other countries where we have ACA programs at this time, do not have a travel advisory related to COVID-19.

It is our intention to keep all programs running as our ACA campuses continue to remain a safe environment for our students. Please be advised that ACA does not offer online courses. We only offer courses taken abroad on our campuses.
